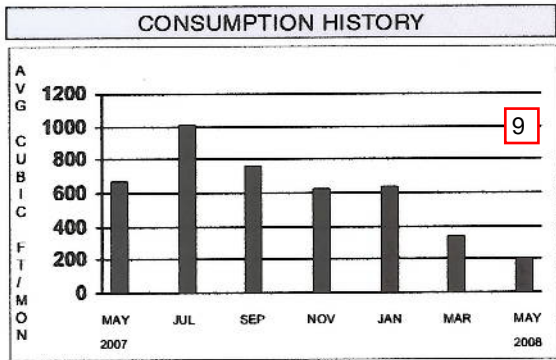

In June, trace amounts of chlorine will be added to wells serving the Manchester Village area. This precautionary measure will add another barrier of protection against possible bacterial growth in the system. Previously, this area received chlorination from water transferred from the upper pressure zone.
